***Re: Rating Letter for BLR of KEI Industries Limited***

India Ratings and Research (Ind-Ra) has upgraded the long-term rating on KEI Industries Limited's (KEI) bank facilities to 'IND AA+' from 'IND AA' with a Stable Outlook while affirming the short-term bank loan rating at 'IND A1+' as follows:
