

INTRODUCTION

Corporate Social Responsibility (CSR) has evolved from a voluntary philanthropic activity to a strategic imperative that drives sustainable business growth while addressing societal challenges. In India, the Companies Act, 2013 made CSR mandatory for eligible companies, requiring them to spend at least 2% of their average net profits of the preceding three years on CSR activities. This legislative framework has transformed the CSR landscape, making India one of the first countries to mandate corporate social spending through law.

The healthcare sector in India faces significant challenges, with inadequate infrastructure, limited accessibility, and high out-of-pocket expenditure affecting millions of families. According to the National Health Profile 2023, healthcare expenditure constitutes approximately 3.6% of India's GDP, with over 60% being private expenditure. This creates substantial financial burden on families, particularly those from vulnerable and marginalized communities seeking treatment at premier medical institutions.

THE EVOLUTION OF CSR REGULATIONS IN INDIA

The Companies (Corporate Social Responsibility Policy) Amendment Rules, 2022, further strengthened the CSR framework by introducing stringent impact assessment requirements. These amendments represent a significant step toward ensuring accountability and transparency in CSR implementation, mandating that companies with CSR budgets of INR 10 crore or more in any fiscal year, and all projects with outlays of INR 1 crore or more, must undertake comprehensive impact assessments by independent agencies.

Key Regulatory Requirements for CSR Impact Assessment:

- Companies with a CSR budget of INR 10 crore or more in any fiscal year and all projects with outlays of INR 1 crore or more must undertake an Impact Assessment by an independent agency.
- Impact Assessment must be conducted at least one year after programme implementation is complete.
- For multi-year programmes, Impact Assessment should be conducted after completion of the programme and a follow-up assessment after one year of programme completion.
- If programmes are renewed or scaled up after each financial year, separate Impact Assessments should be taken up every year.
- Impact assessment related expenditure may be booked as a CSR expense as long as it does not exceed 2% of the total CSR spending or INR 50 lakh, whichever is higher.
- The CSR impact assessment report will be annexed to the annual report on CSR.

METHODOLOGY OF THE STUDY

The following step by step methodology and approach were adopted while conducting Impact study of CSR Project undertaken by KEI Industries Limited for the development of the Madhav Seva Vishram Sadan near AIIMS Rishikesh through Bhaorao Deoras Seva Nyas.

The PHDCCI team visited the Madhav Seva Vishram Sadan on 19th June, 2025 and conducted comprehensive field assessment at the project site in Rishikesh, Uttarakhand.

APPROACH FOR IMPACT ASSESSMENT

The Impact Assessment of the KEI Industries Limited CSR project was conducted through a systematic approach designed to evaluate the effectiveness, sustainability, and social impact of the Madhav Seva Vishram Sadan facility. The assessment employed a mixed-methods approach combining quantitative data analysis with qualitative stakeholder feedback to provide a holistic understanding of the project's outcomes. The primary data collection through beneficiary surveys and stakeholder interviews, secondary data analysis of operational records and financial documents, and on-site infrastructure evaluation to assess the facility's contribution to healthcare accessibility and community welfare.

METHODOLOGY FOR IMPACT ASSESSMENT OF CSR PROJECT

The broad methodology adopted for the Impact Assessment of CSR Project, followed with **IRECS Framework** (Inclusiveness, Relevance, Expectation, Convergence, Service Delivery), is furnished below:



1. PRELIMINARY DATA/INFORMATION COLLECTION:

- Collection of preliminary data/information pertaining to the CSR Project from Bhaorao Deoras Seva Nyas and KEI Industries Limited.
- Evaluation of the available documentation to gain a comprehensive understanding of the project's background and objectives.
- Review of CSR MOU and project proposal documents.

2. PHYSICAL VERIFICATION & STAKEHOLDER ENGAGEMENT:

- · Conducted physical verification of the facility
- Reviewing all relevant documentation related to the project
- Engaging in interviews and discussions with key stakeholders including facility management, and implementing partner representatives.

- Utilized semi-structured questionnaire designed to cover various aspects such as beneficiary backgrounds and overall satisfaction.
- Interviewed facility staff members across different categories.

- Analyzed project's contribution to healthcare infrastructure development
- Evaluated short-term & long-term benefits generated by the project for the target beneficiaries.





ASSESSMENT OF CSR PROJECT

D.1 CSR PROJECT OVERVIEW

The project received an approved fund allocation of INR 1,00,00,000/- (One Crore Only) from KEI Industries Limited. The entire sanctioned amount was effectively utilized for the construction and operationalization of the Madhav Seva Vishram Sadan near AIIMS Rishikesh, demonstrating efficient financial management and successful project execution within the approved budget framework.

KEI Industries Limited provided funding for the healthcare accommodation facility aimed at meeting the accommodation needs of patients' relatives and attendants visiting AIIMS Rishikesh. The project encompassed comprehensive infrastructure development including construction of a multi-story accommodation facility. Bhaorao Deoras Seva Nyas undertook extensive planning and implementation efforts to create a sustainable healthcare support infrastructure in the Rishikesh region.

The project began with detailed planning and site preparation, followed by construction activities spanning from September 2022 to June 2024. The facility was inaugurated on 3rd July 2024 and commenced operations on 4th July 2024.

OBJECTIVE AND EXPECTED OUTCOME OF THE PROJECT

The objective of CSR Project undertaken by KEI Industries Limited through Bhaorao Deoras Seva Nyas:

- To promote healthcare including preventive healthcare by providing affordable, quality accommodation facilities for patients' relatives and attendants visiting AIIMS Rishikesh.
- To enhance healthcare accessibility for families from distant locations and marginalized communities by reducing accommodation costs and improving convenience.
- To provide dignified accommodation services with essential amenities, safety measures, and hygienic facilities for vulnerable families during medical emergencies.
- To create employment opportunities for local community members through facility operations and management.

EXPECTED OUTCOMES:

The expected outcomes of the project include improved healthcare accessibility, reduced financial burden on patients' families, enhanced quality of life during medical treatment periods, sustainable accommodation solutions, employment generation for local communities, and establishment of a replicable model for healthcare support infrastructure development.

The project aims to achieve positive social and economic impacts, including improved healthcare outcomes, community empowerment, and enhanced quality of life for families accessing AIIMS Rishikesh services.

ACTIVITIES AND IMPLEMENTATION

Following steps for implementation of Project:

1. PROJECT PLANNING AND DESIGN:

The first step involved comprehensive planning and architectural design for the Madhav Seva Vishram Sadan. The project scope included construction of a multi-story facility on 3.5 acres of land with 2.5 acres built-up area.

Detailed architectural planning ensured optimal space utilization, safety compliance, accessibility features, and operational efficiency. The design phase involved stakeholder consultations with AIIMS administration, local authorities, and community representatives to ensure alignment with healthcare infrastructure requirements and beneficiary needs.

Peak occupancy occurs during winter months when travel from northern states increases, while monsoon season shows relatively lower occupancy due to travel difficulties.
















D.6 BENEFICIARIES INTERACTION



The Madhav Seva Vishram Sadan has significantly enhanced healthcare accessibility by providing affordable, quality accommodation near AIIMS Rishikesh.




